Akkari, being the duly elected 1st Vice President and Acting President of the Liberia Timber Association (LibTA), a trade association established by an act of legislatures in 1976 and which is also duly recognized and registered with the Liberia Business Registry (LBR) and the Ministry of Finance & Development Planning (MFDP), with Enterprise code: 051664647, and Tax Identification Number: 500492488, as non-for-profit organization, with principal office located in the left wing of the 2nd floor of the headquarters of the Liberia Annual Conference of the United Methodist Church (LAC/UMC), intersection of Tubman Boulevard & 12th Street, do hereby certify that the statement below is a true reflection of a part of the deliberation of an emergency meeting of the Executive Committee (ExCo) of said trade association held Friday, the 8h of August 2024, by Zoom.

WHEREAS, during the Emergency Meeting of the Executive Committee (ExCo) of the Liberia Timber Association (LibTA) held through the usage of Zoom, the Head of Secretariat (HoS) of the Technical Secretariat of LibTA read to the body a letter over the signatory of the Head of Secretariat of the Liberia Extractive Initiative Transparency Industry (LEITI), Mr. Jeffery N. Yates, informing the body that the tenure of its nominee, Mr. E. Ekema A. Witherspoon, I., to the Multi-Stakeholders Group (MSG) of the LEITI would be coming to an end as of the 31st of October 2024 and therefore inviting the body to reconfirm their nominee or file the name of a replacement in keeping with the Act creating the LEITI;

WHEREAS, after the reading of said letter mentioned above, a revision of both the Constitution and By-Laws governing LibTA, specifically relating to appointment, as well as the longstanding traditions relating to the nomination of its nominee to serve on the MSG of the LEITI was done;

WHEREAS, all those presence concurred that the protocols and practices should continue as it has always been; and

WHEREAS, the decision reached during the above stated emergency meeting of the ExCo was circulated to all member companies of LibTA, through the distribution of the minutes of said meeting. TC OF
