WHEREAS, the National Civil Society Council of Liberia (NCSCCL) convened an emergency meeting on October 15, 2024, in response to urgent matters requiring the Council's engagement with the Liberia Extractive Industries Transparency Initiative (LEITI);

WHEREAS, the Council recognizes the critical need for active representation to ensure accountability, transparency, and good governance in Liberia’s extractive industries, aligning with NCSCCL’s mission to promote effective and ethical management of natural resources for the benefit of all Liberians;

WHEREAS, under the guidance and directives of the Council's Chairperson, a resolution was reached following a thorough review of potential candidates qualified to represent the Council at LEITI;

RESOLVED, that Amb. George Kingsley is hereby appointed as the official representative of the National Civil Society Council of Liberia to LEITI;

RESOLVED FURTHER, that Amb. George Kingsley shall uphold the mandate of the Council by advocating for transparency, accountability, and inclusive participation within the LEITI platform, advancing the Council's strategic priorities and strengthening the impact of civil society in Liberia’s extractive sectors;

RESOLVED FURTHER, that Amb. George Kingsley shall periodically report back to the Council on LEITI deliberations, ensuring alignment with the Council's objectives and the overarching mission to foster sustainable development in Liberia.
