I. Introductions & Welcome

An Extraordinary MSG Meeting was held on Wednesday, November 20, 2013 in the Conference Room of the Royal Grand Hotel. The meeting was chaired by the President of the Liberia Timber Association, Mr. John Deah in the absence of the Chair and Co-Chair. The Secretariat received consent from the Office of the Chair to have Mr. Deah chair the meeting. Welcome remarks were made by the Head of Secretariat, Mr. Samson S. Tokpah followed by self-introductions. Each member of the visiting delegation was allowed to introduce himself/herself following which the head of the Ethiopian Delegation, His Excellency H.E Ato Adisu Arega Kitesa, State Minister, Prime Minister Office made a brief remark on behalf of his country/delegation followed by a representative from the Tanzania delegation.

III. Presentation of the Matrix on the Post Award Process Audit

The Secretariat presented a comprehensive summary matrix of the recommendations on the Oil and Agriculture sectors from the Process Audit Report and the MSG Retreat held on June 5 & 6, 2013. Some members of the MSG agreed that there was a need to properly review the report company by company in order to harmonize the recommendations contained therein, while others suggested that the recommendations report be endorsed in its entirety and submitted to the Government for proper investigation.

<u>Decisions:</u> Following much discussions, the MSG agreed as follows:

- 1. That all recommendations from the Process Audit Report are accepted and a formal communication submitted to the Government of Liberia stating the MSG acceptance.
- 2. That a formal communication be drafted for the Government by the Secretariat on the MSG's position. Said communication should be forwarded to the MSG for review and no-objection prior to submission to the Government.
- 3. Those recommendations from the Retreat are excluded from the recommendations submitted to the Government.

IV. Date and Time of the Next Meeting
